Response to March 6, 2024 Requests for Additional Information

To Whom it May Concern:

This letter responds to the two requests for additional information issued by the Federal Election Commission ("FEC") on March 6, 2024. In the process of terminating, the Committee has been in communication with FEC staff, and has followed the guidance provided as to the Commission's procedures. Now, in accordance with several conversations between the Committee's counsel and the FEC's Senior Campaign Finance Analyst, the Committee hereby requests that the FEC administratively terminate the reporting obligations of the Committee pursuant to 11 C.F.R. § 102.4.

For the purpose of administrative termination, the Committee acknowledges the two debts previously reported as owed to AT Publishing and Capital Square Funding Group, LLC will be retained on the Committee's reports as of the administrative termination. With this acknowledgment, the Committee notes that disclosure of the disputed debt does not constitute an admission of liability or a waiver of any claims the political committee may have against the creditor, including, but not limited to, the Alaska statute of limitations which expired before January 1, 2020, with respect to these disputed debts. See 11 C.F.R. § 116.10(a).

In support of its request for administrative termination, the Committee notes that it has been dormant since shortly after the 2016 general election. The following statements apply to recent years:


- The Committee has not incurred any obligations or debts of \$5,000 or more.
- The Committee has had no receipt of contributions since shortly after the 2016 general election.
- The Committee's recent reports reflect expenditures only for the purpose of paying undisputed debts (with campaign funds), and the disbursement to a qualified charity of excess recount funds (which funds could not have been used for the two reported campaign debts).

- The primary purpose of any further reports will be to disclose outstanding debts and obligations.
- The Committee's recent reports demonstrate that there are no outstanding accounts receivable.
- The reported debts and obligations exceed the Committee's cash on hand balance, which is \$0.

Accordingly, the Committee requests that the FEC administratively terminate its reporting obligations.

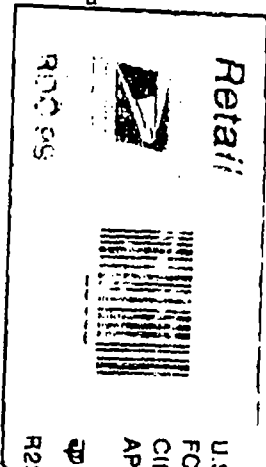

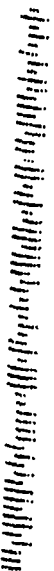
