On December 15, 1993 you were notified that a review of the above-referenced report(s) raised questions as to specific contributions and/or expenditures, and the reporting of certain information required by the Federal Election Campaign Act.

Your December 27, 1993 response is incomplete because you have not provided all the requested information. For this response to be considered adequate, the following information is still required.

-In your letter dated February 19, 1993 you indicate that the discrepancy noted in the beginning cash balance is due in part to an independent auditor's determination that certain items were inadvertently not recorded on past reports.

Please note that in order for your committee to be in compliance with the Act, you must amend any reports which are affected by the discrepancy noted above.

If this information is not received by the Commission within fifteen (15) days from the date of this notice, the Commission may choose to initiate audit or legal enforcement action.
