In January of 2017 this committee changed compliance firms, and the incorrect prior report was based on information that was overlooked as a result of that changeover. Additionally, following an internal audit, many 2016 reports were amended significantly, and this amendment reflects those changes carried though. Finally, the Column B year to date figure for Itemized Contributions is a combined Itemized and Unitemized contributions. The correct figures should be Column B, 11(a)(i) YTD Itemized 45015.16, and Column B, 11(a)(ii) YTD Unitemized 98482.26. This discrepancy is the result of being unable to manually adjust the particular figures in FECfile.
