-The beginning cash balance of this report should equal the ending balance of your 30 Day Post-General Report. Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.


-Your calculations for Lines 7 and 23, Column B appear to be incorrect. FEC calculations disclose these amounts to be \$23,000, respectively. Please provide the corrected totals on the Summary and Detailed Summary Pages.

-Line 23 of the Detailed Summary Page of your report discloses a total of \$1,000 in contributions to federal candidates/committees. The sum of the entries itemized on Schedule B, however, indicates the total to be \$0. Please amend your report to clarify the discrepancy.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. If you need assistance, please feel free to contact me on our
