This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The totals listed on Lines 6(c), 7, 11(a)(i), 11(a)(ii), 17, 21(b) and 23, Column B of the Summary and Detailed Summary Page(s) appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B total. Please amend your report and any subsequent reports that may be affected by this correction.


-It appears that the figures you have disclosed on Lines 28(d) and 30 of the Detailed Summary Page have been inadvertently recorded on the incorrect lines. Please amend your report to disclose your figures on the correct lines of the Detailed Summary Page.

-Line 23 of the Detailed Summary Page of your report discloses a total of 50 in contributions to federal candidates and other federal committees. The sum of the entries itemized on Schedule B, however, indicates the total to be \$16,400. Please amend your report to clarify the discrepancy.

-Please amend Schedule B that apparently supports Line 23 by providing the congressional district and address for each contribution made to a federal candidate or political committee. 11 CFR §104.3(b)(3)(ii) and (v)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
