Attached is an Amended October Quarterly Report (9/1/94-9/30/94) Schedule B for the Kennecott Corporation Political Action Committee (PAC). On December 7, 1994 The Kennecott Corporation Political Action Committee sent an amended report reallocating \$3,000 from Senator Orrin Hatch's general election campaign fund to the primary election fund, and had labeled it as a debt retirement. This was done on the advice of Erica Holder of the FEC in response to questions regarding a sequence of contributions made to Senator Hatch's campaigns.

On January 3, 1995 Kennecott received a second letter from the FEC stating that the amended report filed was incomplete because the Hatch Election Committee had sufficient funds to retire all of their debt.

In order to eliminate any potential controversy with the FEC, The Hatch Election Committee has issued a check for \$1,000 to The Kennecott PAC, a copy of which will be forwarded to you when received. The remaining \$2,000 contribution is now reallocated to the General Election Campaign by this amended filing.

The Kennecott PAC was well within its spending limits in this process. Regrettably, with misinformation and clerical errors the \$1,000 refund seems the only way to technically comply with all regulations.
