Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 1 item(s):

- The beginning cash balance of this report does not equal the clarification that you provided in response to a Request for Additional Information (RAFI) sent on your 2022 Year-End Report (11/29/22 -12/31/22). The Commission notes the miscellaneous electronic submission (FEC Form 99) stating, "Separately, Uropartners LLC PAC would like to update and Amend its Year End 2022 Report and specifically update the Cash On Hand Balance. This Balance should reflect an amount of \$26,411.62 for the Cash on Hand at Close of Reporting Period - the same amount reflected in the Post-General Election Report. Our software system was updated and required us to download a new FEC File at the time we filed the 2022 Year End Report. We were not aware that the Cash on Hand Balance would not carry-over from the previously filed Post-General Election Report. As a result, when we filed the Year-End, 2022 Report, the "Cash on Hand" was not accurate. The current Cash on Hand should be updated to consistently reflect an amount of \$26,411.62 - the same amount as reflected in previous reports." Please correct this discrepancy and amend all subsequent reports(s) that may be affected by the correction. (52 U.S.C. §30104(b)(1))

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to

taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
