Dear Montine:

During the last the sixteen months, Chairman Tom Kershaw and I have had the opportunity to discuss with you the various alternatives for your state entering the dual membership program. While we all agree philosophically and strategically that dual membership is a good program and the members want dual membership, we are not always in sync on how soon we can tactically implement and still meet our fiscal responsibilities to our respective associations. As we see it there are two major concerns which non-dual state associations still have. The first -- what will be the attrition impact of raising dues on membership numbers? And the second -- if the state association raises dues for dual membership, then the SRA will not be able to directly reap any of the benefits of that increase for state association programs.

To answer the first question, 47 states have entered the program and many states have raised their dues to cover the cost of the dues they forward to the NRA. No one has ever reported a significant attrition after dual membership -- though many expected it. New states have marketed the dual membership program to their membership as \$500 worth of benefits and services which are easily worth the deeply discounted \$50 price tag the member is being asked to pay. The members understand and appreciate this NRA sacrifice and every state reports growth, not decline, after becoming a dual member state.

The second concern is more tactical. How can both the state and the national meet their budgetary goals and still have room to grow? In light of this second concern we are putting forth a new proposal for dual membership which we believe is a win-win-win, -- a win for the members, a win for the state association and a win for the National Restaurant Association. This new proposal for dual membership is based on the state restaurant association agreeing to dual membership and raising their current dues rates by \$50 per member. The basis for this increase in dues would be the additional \$500 in services that their members will be provided by becoming members of the National Restaurant Association. This means that the actual cost to the member would be only 10% of the actual services delivered, meaning an automatic 90% discount. Further, if joining the Association separately, the average dues for a single member would be roughly \$250 to \$300. Again, at \$50, the deep discount received would be somewhere between 80% to 85% off the regular member dues.

The new plan would call for the state to actually collect \$50 from each of their renewing members, and forward the full \$50 to the National Restaurant Association. As an introductory consideration, the National Restaurant Association in turn would retain an amount that was \$10 year one, \$20 year two, \$30 year three, \$40 year four, and finally the full \$50 in year five. The balance between the amount the Association retains and the amount sent by the SRA would be returned to the SRA to use for marketing and program considerations and to encourage membership growth. Under this

plan the state could use 80% of the first year's renewing dues, 60% of the second year's renewing dues, 40% of the third year's renewing dues, and 20% of the fourth year's renewing dues, for the state's internal programs and marketing. In year five, it would have been four years since a dues increase, and the states could consider again raising their member dues.

For new members joining the SRA after the dual membership program has begun in the state, a full \$50 would be forwarded to the NRA the year the member joined and for each renewing year thereafter. These members would be exempted when calculating the promotional disbursements returned back to the state.

Chain headquarters and high volume independents, currently billed by the National Restaurant Association, would continue to be billed by the Association with an agreed upon percentage forwarded to the state association in which the member is headquartered to cover SRA membership dues in that state.

Under this plan revenue from additional MOM mailing services would be kept by the NRA and not shared with the state until such time as the states dues were at a full \$50 per head. At such time when the state reaches \$50 per head, dues will be split equally between the national and state association.

All other services and benefits which currently are available to dual states, as outlined in the dual state brochure, are available from day one of the program, including the services of Marketing General Inc.

This new proposal is intended to ease the immediate financial hit of a state association when entering the dual membership program, while still moving the state toward the \$50 expectation for all dual state partners.
