
Dear Mr. Decker:

Leadership for America's Future PAC (LEAD PAC, FEC ID# C00342378) is in receipt of your Request for Additional Information dated May 4, 2005. Your letter addresses LEAD PAC's multi-candidate status, and certain contributions LEAD PAC made during 2004. Thank you for bringing this matter to our attention.

LEAD PAC recently filed its FEC Form 1M (copy enclosed), indicating that LEAD PAC qualified for multi-candidate status on March 15, 2004. The contribution to the DeMint for Senate Committee was the 5th contribution made by LEAD PAC to a federal candidate, thereby completing the qualifying process. All other donations referenced in your letter were thus made when LEAD PAC had multi-candidate status, and when LEAD PAC was able to contribute up to the applicable limit of \$ 5,000 per candidate per election.

However, we recognize that the contribution to the DeMint for Senate Committee should not have, at that point, exceeded \$ 2,000 per election, and we have obtained a refund (copy enclosed) from the DeMint campaign in the amount of \$ 3,000. This refund will, as your letter directed, be disclosed on our mid-year 2005 FEC report.
