Reference: Redesignation of Check 631 for James Moran for Congress

In reply to your letter of April 4, 2001, in which you request clarification of the Schedule B contribution line for APA-PAC check #681 (see attached copy of page 5 of 5 in Schedule B);


- (1) The check number should have been #631, not 681, a typo. The original check #631 was issued to Jim Moran in April 1999; it was reported to the FEC as a "Primary Election" contribution on our semi-annual report for January-June 1999. In March 2000, we were advised that the check had been lost, voided it, and re-issued a new check, #665. The Void of Ck 631 and the reissue of Ck 665 were reported to the FEC on our Quarterly report for the period January 1-March 30, 2000.
- (2) In September 2000, the Voided Check #631 was presented by the Moran campaign to our bank, and it was paid. The APA PAC Committee authorized Moran to keep the second check. The check was then reported on the FEC report for the period July-September, 2000. This is the item that you are questioning. We reported it again since it had not been voided, and had fully intended for it to be used for the Primary election.
- (3) A letter (copy attached) has been sent to the Moran Campaign Hqtrs to redesignate the check from the Primary to the General Election.

We apologize for the confusion surrounding this contribution to Congressman Moran—and assume that the prompt redesignation request to his campaign headquarters will satisfactorily correct this matter.
