After an extensive reconciliation and review process of our VOCUS computer system to our bank account, we have determined that the ending balance as of 06/30/08 is \$14,449.25. Our bank statement shows a balance of \$13,308.47 with \$2,250.00 in outstanding checks, a deposit of \$2,394.78 not on the bank statement or recorded in VOCUS and bank fees of \$131.03 not recorded in VOCUS but on the bank statement. According to our records, all transactions from 2002 until the present are accurately reflected in our VOCUS system. We believe that the correct beginning balance did not carry forward from our old system to the VOCUS system that we use now. Hence, all receipt and disbursement transactions since 2002 have been accurately reported, just the beginning and ending balances were incorrect. Attached is the amended Third Quarter report that shows the correct balance at 06/30/08 which is the Cash on Hand at Beginning of Reporting Period (Column A – line 6b). This ending balance will be the beginning balance on our 12-Day Pre-General report which will be amended and resubmitted. Since we believe that this error happened on or before 2002, the Cash on Hand January 1, 2008 (Column B line 6(a)) also had to be changed in order to reflect the correct Cash on Hand at Close of Reporting Period. The amended Cash on Hand January 1, 2008 amount will be reflected in subsequent filings. The bank statement from Blue Flame Credit Union, the bank reconciliation that I prepared and the VOCUS Bank Reconciliation Report is on file in our office which will be used as documentation for the adjustment.
