Re: Request for Additional Information

This letter is sent in response to your request for additional information, dated February 10, 2009, concerning the 30-day Post-General Election Report.

Item #1: You ask about Line 12 of the Detailed Summary Page, which discloses transfers from Joint Fundraising Committees. The total transfers on the post-general report exceed the memo contributions reported; however the total memo contributions reported Coast to Coast Victory 2008, Louisiana North Carolina Senate Victory 2008, Maine-North Carolina Senate Fund, Senate 2008, Senate Challengers Fund, and Voices for a Senate Majority exceed the total transfers made during the existence of the joint fundraising committees. All memo contributions raised through these joint committees has been reported on this report and prior reports.

Item #2: You ask about the refund from the Share Group in the amount of \$5,977.50 reported on line 15 of Schedule A and a corresponding credit on Schedule B, the Post-General report has been amended and filed with the Secretary of the Senate to address this item.

Item #3: Regarding the 48-hour reports, we have reviewed the list provided and indicated on the attachment to this letter the contributions that were included in the 48 hour report and filed with the Secretary of the Senate as required.

Item #4: The campaign received a contribution from Diane Reaud in the amount of \$4,600.00 on October 16, 2008, this was reported on the 48 hour reports as two contributions of \$2,300 in error. On November 12, 2008 Ms. Reaud was refunded \$2,300.00.

Item #5: The Post-General report has been amended to reflect the memo entry for the disbursement to Bank of America of \$15,100.31.

Item #6: This issue is being reviewed and the appropriate steps will be taken to address it, including notifications and any amendments necessary.
