The sum of the entries for the total in the "Calendar Year-to-Date", Line 11(a)(i), Column B on the Detailed Summary Page were incorrectly totaled. The correct total of Line 11(a) Column B should be \$4,970.25, and the total for Line 11(i) Column B should be \$123,925.87.
