Dear Ms. Huff:

It has come to my attention that, due to an inadvertent error, the date of a contribution to a non-Federal candidate committee disclosed in the UST Executives, Administrators and Managers Political Action Committee "Twelfth Day Report Preceding the Runoff Election on June 5, 1993 in the State of Texas" was incorrect.

The contribution in question was for \$500, made to the Pennsylvania Senate Republican Campaign Committee and reported on Page 1 of the Schedule B for Line 29 as having been made on April 21, 1993. The correct date of the contribution was May 6, 1993. All other aspects of the contribution are as reported.

As this change does not affect any balances on the Schedule B for Line 29 on either page of the Form 3X filed with the above referenced report, I understand that a letter amendment is sufficient to correct the inaccuracy. Mr. Leigh Snell with Public Affairs Support Services (PASS) confirmed this with you in a recent telephone call.
