


Dear Ms. Durkee:

This letter is to formally request a refund in the amount of \$3,000 from the Feinstein for Senate committee. We have recently received notice from the Federal Election Commission stating that we have exceeded the limits set forth in the Act. 2 U.S.C. §441a(a). The contributions in 2003 and 2005 were originally designated for primary elections in 2003 and 2008, however because the candidate did not participate in primary elections those years the funds were attributed to the next scheduled Federal election for this candidate, the 2006 Primary. This along with our most recent contributions in April of 2006 has put us over the limit amount of \$5,000 by a total of \$3,000.

Upon receipt of the refund we will re-contribute the \$3,000 and designate the funds for the 2006 general election.



