We are in receipt of your letter dated July 6, 2011 requesting additional information on SEIU's Year End Report, October 1, 2010 through December 31, 2010 (copy enclosed). Your letter indicates that no contributions are disclosed on Line 6, "Total Contributions" and that each contributor who made a donation in excess of \$200 used to fund the independent expenditure(s) must be itemized on Schedule 5-A, including their identification information.

Please be advised that the independent expenditures disclosed were made from SEIU's general funds, which do not contain contributions in excess of \$200 solicited or received for purposes of paying for Federal independent expenditures. Accordingly, the report correctly indicated that SEIU did not receive any contributions in excess of \$200 or more for purposes of furthering the disclosed independent expenditures. Additionally, SEIU is not a qualified nonprofit corporation so the disclosure requirements applying to qualified nonprofits do not apply to SEIU.
