

The above referenced reports correctly reflected the administrative expenses for Defend America PAC. The administrative expenses reflected in the reports correctly reflect payments made for the purpose of operating Defend America PAC, which included expenses for a post office box, postage stamps, stationary, envelopes, reception expenses, consulting and fundraiser fees, an Internet Web page, accounting and preparation of FEC report fees, supplies, software for FEC reporting, and other operation expenses. Administrative expenses recently received and paid in 1998 and 1999 were reflected in the monthly reports. There were no goods or services provided to the committee by any other person, committee, entity, except as reflected in the above referenced reports.

With respect to your second letter regarding the February Monthly Report (1/1/99-1/31/99), our report incorrectly stated the amounts for Line 6(a), Column B and Line 6(a), Column A. As a result of a typing/clerical error, the cash on hand January 1, 1999 and the cash on hand at beginning of reporting report (also being January 1, 1999) was incorrectly stated as \$131,458.63. The correct amount for both line items should have been \$131,974.17 which is consistent with the 1998 Year End Report. Please note however that the typing error did not affect any other line items for this reporting period as they were correctly calculated using the correct beginning balance. The subsequent reports also appear to not be affected by this correction. I have attached an amended Summary and Summary Detailed Pages for this reporting period.
