-Your report discloses activity that falls outside the reporting period. Please amend this report by including only the financial transactions that occurred between 7/1/95 and 12/31/95. Any activity occurring outside this reporting period should be included in the appropriate report(s). 2 U.S.C. §434(b)

-Your calculations for Lines 6(c) and 7 appear to be incorrect. FEC calculations disclose these amounts to be \$560.41 and \$300.00, respectively. Please provide the corrected totals on the Summary Page.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
