This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your calculations for Lines 21(a)(i), 21(a)(ii), 21(c), 30, and 31 appear to be incorrect. FEC calculations disclose these amounts to be \$41,361.87 \$4,205.93, \$50,539.53, \$54,425.53, and \$50,219.60, respectively. Please provide the corrected totals on the Detailed Summary Page.

-The totals listed on Lines 21(a)(i), 21(a)(ii), 21(c), 30, and 31, Column B of the Detailed Summary Page appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B total. Please amend your report and any subsequent reports that may be affected by this correction.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
