Dear Mr. Gibson:

The 1993 Minnesota legislature passed the 1993 campaign finance reform act which was effective May 21, 1993. The impact of the act was that political committees and political funds could not accept contributions for an individual, political committee, political fund in excess of \$100 a year. As a result, the Dorsey Political Fund was divided into three separate entities: the Dorsey Political Fund for state and Minnesota county candidates; the Dorsey National Fund for national candidates and the Dorsey Midwest Fund for regional candidates. FEC form 1, Statement of Organization, was filed with the Federal Election Commission on January 11, 1994.


In order to comply with Minnesota's newly-enacted law regarding contribution limits, checks from the Dorsey Political Fund were issued as follows and duly noted on the January 31, 1993 Year End Federal Election Commission Report:

12/30/93	Dorsey National Fund	\$8,122.47
12/30/93	Dorsey Midwest Fund	\$8,122.48

As a result, the cash on hand as of January 1, 1994, for the Dorsey National Fund was \$8,122.47 and was duly noted on the April 15, 1994, Federal Election Commission quarterly report.
