This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Please provide a Schedule B to support the entry reported on Line 22 of the Detailed Summary Page. Each transfer-out to an affiliated committee must be itemized on Schedule B regardless of the amount transferred. 2 U.S.C. \$434(b)(6)(B)(i)

-Your calculations for Lines 21(b), Column A through 30, Column A appear to be incorrect. FEC calculations disclose this amount to be \$6,324.09. Please provide the corrected totals on the Detailed Summary Page.

-Your calculations for Lines 21(b), Column B through 30, Column B appear to be incorrect. FEC calculations disclose this amount to be \$10,429.85. Please provide the corrected totals on the Detailed Summary Page.

-Please use the coverage dates 4/1/96 through 6/30/96 when amending your report.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
