Dear Mr. Ryan:

We recently submitted amendments to several of our 2000 reports. Enclosed are amended reports for February 2001 (1/1/01 - 1/31/01), March 2001 (2/1/01 - 2/28/01), April 2001 (3/1/01 - 3/31/01), and May 2001 (4/1/01 - 4/30/01). Following is a detailed explanation of all corrections:

On the February report (covering period 1/1/01 - 1/31/01), Line 6(a) and (b) were changed to reflect Line 8 column B reported on our amended January report (covering period 12/1/00 - 12/31/00.) We also mistakenly reported a refund of a contribution as a negative receipt. This has been corrected and reported on Line 28(a). Also, a \$200.00 contribution reported as Unitemized has been moved to Itemized because the total for that contributor for that month is \$300.00. Finally, on the February report, we failed to include \$300.00 of unitemized contributions on Line 11(a)ii.

On the March report (covering period 2/1/01 - 2/28/01), Line 6(a) and (b) were changed to reflect the amended February report.

On the April report (covering period 3/1/01 - 3/31/01), Line 6(a) and (b) were changed to reflect the amended March report. Also on the April report, we mistakenly itemized a contribution of \$200.00. The amended report now lists this contribution on Line 11(a)ii.

On the May report (covering period 4/1/01 - 4/30/01), again, we mistakenly itemized a contribution of \$200.00. The amended report now lists this contribution on Line 11(a)ii.
