
Re: Toomey for Senate, C00461046, October Quarterly Report 2010

Our FEC analyst has asked me to clarify a number of items that appear on our October Quarterly report. The items in question are related to earmarked and conduit contributions.

1. On our report you will see a number of contributions from the Senate Conservatives Fund. These contributions are not from a PAC, they are checks consisting of earmarked contributions received by the Senate Conservatives Fund for Toomey for Senate. Our report reflects the total received for both the period and the cycle. We then use memo entries to link the conduit contribution to the individual contributors. Any difference between the total contribution you see on the report and the memo totals which also appear on the report equals un-itemized contributions. A very large percentage of the contributions received through the Senate Conservatives Fund are lower dollar contributions and are therefore un-itemized for reporting purposes.
2. We also receive earmarked contributions received by the Madison Project for Toomey for Senate. These are handled exactly the same as in #1 above. Again, any difference between the total contributions you see on the report and the memo totals equals un-itemized contributions.
3. Our report also contains a number of contributions which are reflected as being "Earmarked through Club for Growth PAC". These are bundled contributions. On the advice of our FEC analyst I include a memo text item with each report that provides a total for the bundled contributions received from these groups in each reporting period. For your records, the total bundled earmarked contributions received from the Club for Growth PAC are as follows:
Primary 2010 = \$721,176.28 , General 2010 = \$244,079.00, Primary 2016 = \$1,275.00


