This letter is prompted by the commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-There should not be a gap in the coverage dates for your reports. An amended Year End Report is necessary to disclose the activity from 7/1/93 through 7/30/93.

-The total listed on line 11(a)(1), column B of the detailed summary page appears to be incorrect. Please be advised that you should add the "calendar year-to-date" total from your previous report to the current "total" figure from column A to derive the correct line 11(a)(1), column B total.

-Please provide the total for line 22, column B of the detailed summary page.

-For your information, all contributions received that aggregate \$200 or less per individual for the calendar year should be reported on line 11(a)(11). Contributions received aggregating over \$200 per individual for the calendar year should be reported on line 11(a)(1) and itemized on schedule A.

-Your report discloses \$250 in non-federal disbursements, however, you have failed to disclose this amount on the detailed summary page. Contributions to non-federal candidates/committees should be properly disclosed on line 29 of the detailed summary page.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this
