





Dear Sir:

In compliance with Federal Election Commission (FEC) regulations, and for the reasons set forth below, the Holland & Knight Committee for Effective Government (H&KCEG) hereby requests a refund from your Committee in the amount of \$1,500. We regret the inconvenience that the refund will cause.

By check numbered 2039 and dated July 20, 1998, the H&KCEG contributed \$1,500 to your Committee that was designated, on the face of the check, for the 1998 primary election. The 1998 primary election your candidate faced was held in Indiana on May 5, 1998; thus, the H&KCEG contribution was made after the election for which the contribution was designated. FEC regulations provide that a contribution designated in writing for a particular election, but made after that election, shall be made only to the extent that the contribution does not exceed net debts outstanding for such election (11 CFR 110.2(b)(3)). When I inquired by telephone on November 4, 1998, your Committee's staff advised that, at the time of the H&KCEG July 20, 1998 contribution, your Committee had no net debts outstanding from the 1998 primary election.

Regrettably, the H&KCEG cannot simply redesignate the \$1,500 contribution of July 20, 1998 to be a contribution for the 1998 general election instead of the 1998 primary election. Since the 1998 general election has already occurred, the H&KCEG could redesignate the contribution for the general election (making a post-election contribution for the general election) only if your Committee has net debts outstanding from the campaign for the general election. Your staff advised me, in our conversation of November 4th, that your Committee had no net debts outstanding from the campaign for the general election. Accordingly, no option is available to the H&KCEG other than to request that your Committee refund \$1,500 to the H&KCEG.

Congratulations on Senator-elect Bayh's victory; we look forward to working with him in the future.
