This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 1 item(s):

- The beginning cash balance of this report does not equal the ending balance of your 2012 Year-End Report (11/27/12-12/31/12). Please correct this discrepancy and amend all subsequent reports(s) that may be affected by the correction. (2 U.S.C. § 434)(b)(1))

The Commission notes your memo text in which you state "ORBPAC is aware that the 2012 Year-End Report ending balance does not match the beginning balance on this 2013 Mid-year report. Due to a discrepancy between the PAC account balance and the report balance that recently came to ORBPAC's attention, we are conducting an internal audit of the PAC's books and records and will file amended reports to correct this discrepancy as necessary. The amounts reflected in this report are the current, accurate balances for the PAC account."

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will**
