This letter is in response to your correspondence of 1/14/98 itemizing your concerns found in your preliminary review of the report referenced above.


1. Enclosed is the Schedule H1 to disclose the ratio for allocation of administrative and generic voter drive costs, which was inadvertently omitted from the original filing.

2. The Schedule A for Line 12 you referenced, was included in error. The total does not appear on the detailed summary page, so please remove that schedule from the report. The Schedule H3 is accurate, and is reflected properly on the detailed summary page, line 18.

3. I do not see that the EVENT YEAR-TO-DATE calculations are in error. The Schedule H3 itemizes each transfer that was made from the non-federal account. The treasurer states that the transfers were made only when needed.

If this letter does not clear up your concerns, please advise, with detailed explanation, what you need.
