-Schedule D discloses \$11,217.34 in payment(s) this period to the IRS; however, there are \$8,367.81 in payments reflected on your disbursement schedules. Please amend your report to clarify this discrepancy.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days
