Thank you for your letter of August 4 requesting clarification of the committee status for the Libertarian Party of Michigan Federal Fund (LPM Federal Fund).

The committee that was previously registered with the F.E.C. (the LPM Campaign Fund) was used as a campaign fund for both federal and statewide candidates. Its funds were solicited for federal purposes as provided under federal law, so they could be used for either federal or state candidates. It was our impression that a separate committee was needed for federal candidate campaigns. That is why our new Statement of Organization was filed and the LPM Campaign Fund is being terminated. After speaking with your office we now understand that we could have just changed the name.

We also learned from your office that there is only one state Libertarian Party committee allowed in each state. The letter of 8-4-04 says that Advisory Opinion 2002-10 defines a state committee as "the organization which, by virtue of the bylaws of a political party, is responsible for the day-to-day operation of such political party at the state level, as determined by the Commission."

Therefore, the amended Statement of Organization enclosed lists the state committee as the Libertarian Party of Michigan (LPM). It is our understanding that the only F.E.C. reporting requirement is for funds raised and spent on federal candidates from the LPM Federal Fund, which is a separately funded account of the LPM created for that purpose.

Your office also informed us in a telephone call today that we do not need to petition the Commission for an advisory opinion to determine if the LPM satisfies the criteria for state party status, as the previous committee was so approved and it is the same organization with the same bylaws, as amended at convention from time to time.
