This is filed in response to your letter of August 16, 2006. As to the first matter, in accordance with FEC guidelines, Herbalife maintains a revolving account funded from transfers from Herbalife PAC to pay in advance for any goods or services utilized by the PAC for matters that constitute in-kind contributions. The funds transferred from the PAC to Herbalife are disclosed as such on the Herbalife PAC disclosure reports. The value of the goods and services are deducted from this revolving account and disclosed as in-kind contributions to specific federal committees. These transactions are shown as memo entries. In the matter at issue, the item was reported as a disbursement and should have been reported as a memo entry, since the funds constituting the disbursement had already been reported as a transfer of funds to the revolving account. This amendment discloses the transaction as an in-kind memo entry. As to the second matter, one thousand dollars (\$1,000) has been redesignated as a general election contribution to the Hatch Election Committee, Inc. for the general election and notice has been provided to that committee and a copy is being sent to the FEC.
