This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in enforcement action.** Additional information is needed for the following 1 item(s):

- Invested funds, or funds in a savings account, should be included in your cash on hand figures on Line 8 of the Summary Page. Payments made for investment should not be reported as disbursements, and funds withdrawn from investment accounts should not be reported as receipts. Please amend your disbursement totals, receipt totals and cash on hand figures to correct this error. (11 CFR § 104.3(a) and (b))

This error may have affected the Summary and Detailed Summary Page information on subsequent reports. You should provide amendments for subsequent reports to disclose any changes in beginning and ending cash on hand figures.

Note that any interest received by the committee from any one source aggregating in excess of \$200 in a calendar year must be disclosed on a Schedule A and reported on Line 17 of the Detailed Summary Page information.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to

taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
