The purpose of this letter is to provide an explanation for the amended return that is attached.

During the period 7/1/11 - 12/31/11, a check was made out to "Kathy Hochul for Congress" in the amount of \$500. This check was never cashed, and therefore on 4/19/12 a stop payment was issued. For this reason, we are amending Form 3X for the period 7/1/11 - 12/31/11 to reflect the increase of \$500 of cash on hand at the close of the period. The originally filed report had shown \$684.02 as the ending amount, and now the amended report shows \$1,184.02.

For the period ending 3/31/12, the Form 3X is being amended to reflect the changes mentioned above, which carried forward to affect the beginning cash on hand for the period 01/01/12 - 03/31/12. The originally filed report had shown \$684.02 as the beginning cash on hand and \$114.02 as the cash on hand at the close of the period. The amended report now shows \$1,184.02 as the cash on hand at the beginning of the period and \$614.02 as cash on hand at the close of the period.
