This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The Summary Page discloses \$5,351,32 on Line 6(c), Column A, but the Detailed Summary Page shows the Line 19, Column A total to be \$7,950. These figures should be the same. Please amend your report accordingly.

-Please provide the total(s) for Line 11(d), Column A of the Detailed Summary Page. Note that changes in your figures may affect your Column B totals on this report and/or on subsequent reports.

-Your calculations for Lines 19, 20 and 31, Column A appear to be incorrect. FEC calculations disclose these amounts to be \$7,950 and \$10,000, respectively. Please provide the corrected totals on the Detailed Summary Page.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
