

This is in response to your letter to the Mark Pryor for U.S. Senate Committee, dated August 30, 2007, concerning the Committee's July Quarterly Report (4/1/07 – 6/30/07).

After receiving your letter, the Committee conducted a review of the election cycle-to-date totals of the contributors itemized on Schedule A of our report, as specified by the Commission in its letter to the Committee, and then consulted with you by phone. The following is an item by item response to the Commission's inquiry and reflects the findings we discussed on the phone.

- 1) Jack M. Campbell's original contribution of \$1000 was received on 1/22/2007 and reported using his nickname, Mac Campbell. It was reported on page 55 of the 2007 April Quarterly Report. His second contribution of \$250 was reported under his full name, Jack MacGregor Campbell. The records were combined when it was discovered that there were duplicate entries. His cycle-to-date aggregate total is \$1250, as reported.
- 2) The Cellular Telecommunications and Internet Association PAC has made eight contributions to the Committee, for a cycle-to-date aggregate total of \$8000. One contribution of \$1000, however, received on 2/7/2007 and reported on page 373 of the 2007 April Quarterly Report, was reported by the PAC's acronym, CTIA. All eight entries were reported under the same FEC ID Number, C00262295. The records were combined when the duplicate entries were discovered. The cycle-to-date aggregate total reported is accurate.
- 3) Vernon Clark has made two contributions to the campaign this cycle. Both were accurately reported by the Committee. The first was for \$1000, was received on 5/1/2005, and was reported on page 5 of the Committee's 2005 July Quarterly Report. The second contribution, in the amount of \$1000, was received on

- 4) 6/29/2007 and reported in the July Quarterly Report on page 47. Mr. Clark's cycle-to-date aggregate total is \$2000.
- 5) Contributions made by the Long Law Firm, a partnership, were accurately reported by the Committee. The first was for \$500 and was received on 5/1/2005. It was reported on page 14 of the Committee's 2005 July Quarterly Report. The second contribution, in the amount of \$1000, was received on 6/7/2007 and was reported in the 2007 July Quarterly Report on page 236. The cycle-to-date aggregate total for the Long Law Firm is \$1500.
- 6) A \$1000 contribution from St. Paul Travelers Companies Inc. Political Action Committee, FEC ID Number C00376376, was received on 6/27/2006, and reported on page 35 of the Committee's 2006 July Quarterly Report. A \$1000 contribution was received from The Travelers Companies, Inc. Political Action Committee on 5/10/2007 and was reported using TPAC, a pacronym, on page 316 of the Committee's 2007 July Quarterly Report. Both entries are reported under the same FEC ID Number, and their records were combined when duplicate entries were discovered. TPAC's cycle-to-date aggregate total is \$2000 and was accurately reported.


