This Post-Runoff report was triggered by a contribution made to Georgia Senator Saxby Chambliss for his December 2, 2008, runoff election. Because of the timing of the runoff and Post-General reports, preparation for the Post-General report that was due on December 4, 2008, proceeded as scheduled and it was not until the Post-General had been filed that it was discovered that a Pre-Runoff report was triggered. Based on guidance provided by FEC RAD Analyst Corbin Jones, an amended Pre-Runoff and Post-General report were not filed, but rather noted on this memo entry.
