On April 12, 2010 HALPAC wrote check #3859 to Gene Green Congressional Campaign committee C00254185 in the amount of \$1,500.00. HALPAC incorrectly designated this contribution to the 2010 US Primary election. Mr. Green is a Federal candidate from Texas, and the Texas Primary election had occurred in March, 2010.

HALPAC redesignated this contribution to the 2010 US General election on May 21, 2010. As we did not request the campaign committee return the check, HALPAC will void the initial contribution to the Gene Green Congressional Campaign committee designated to the US Primary election and record a new contribution to the Green committee designated to the US General election in May business. This activity will be reported on the FEC report due June 20, 2010.
