We are in receipt of your letter dated October 18, 2000, a copy of which is attached, in which you request modifications to the PAC's initial filing. Your letter notes two issues which need to be addressed, a Detailed Summary Page and report coverage dates.

During your recent conversation with Ms. Shawn Ennis of our office, you noted that the PAC's initial reporting period should begin on the date the PAC first filed with the FEC, which was October 20, 1999, rather than November 1, 1999 as was previously reported.
