Best Efforts: A request is made of each contributor for employer and occupation information with an initial solicitation in the form of a uniform reply card requesting the necessary information. In the event the contributor fails to comply, they receive a follow up letter within 30 days of the contribution requesting the information and providing the contributor with several methods (e.g. telephone, e-mail, fax, return envelope) to supply the necessary information. In addition, staff queries the event host, online databases and other sources of employer and occupation information in order to determine the information. If the information is still unavailable, the campaign deems that it has used its best efforts to comply with the regulations in this area. Reports are amended as additional contributors provide their employer and occupation information.
