Dear Mr. Ryan:

This letter is in response to the problems you identified with National Pork Producers Council Pork PAC FEC filings, per your letter of November 7, 2013.

Corrective Actions

1. We have worked with our PAC software company to correct the system errors that were indicating "2013" elections, where "2014" elections should have been reported. We will be amending the Mid-Year Report (1/1/2013-6/30/2013), so that elections are accurately reported.
2. Regarding Friends of Dick Durbin Committee, the following corrections have been made, and will be shown as memo corrections on our 2013 Year-end report.
 - a. Disbursement reported 7/8/2010 was incorrectly reported as general-2009. It was for primary-2014. This is consistent with how it was reported to FEC by Friends of Dick Durbin Committee.
 - b. Disbursement reported 4/1/2011 was incorrectly reported as primary-2014. It was for general-2014. This is consistent with how it was reported to FEC by Friends of Dick Durbin Committee.
