Enclosed find check images and other documentation in support of electronic disclosure filings for our campaign. On this date amendments were electronically submitted to FEC which updated campaign reports all the way back to July. The purpose of these amendments were:

- Remove certain disbursements from a list of debts from the pre-Primary period, and show these
  disbursements as they were paid in the post-Primary period. There were no net-debts from the
  pre-Primary period.
- Refund or redesignate contributions that were mistakenly submitted for payment of Primary debts.
- Refund a small contribution that exceeded the \$2600 contribution limit for an individual for the Fall election.
- Correct contributions from the candidate that were mistakenly listed as contributions by an individual.

As refunds were only made recently (after being notified by you of the problems) details of these transactions will appear in the January 31 Year End Report. We'll keep the campaign open in 2015 as we work through debts which we owe to the candidate.
