Of the transfers disclosed in the above referenced Report which were shown in the Report to have been from the Republican National Committee we are submitting the following explanations:

1. Transfer in the amount of \$103,170.00 dated July 22, 1996 - This was a transfer from the TN State Operating Account. Check No. 1001 (Copy of check is enclosed).
2. Transfer in the amount of \$190,806.18 dated August 5, 1996 - This was a bank transfer from the TN State Operating Account. A copy of the transfer advice from First American Bank is enclosed.
3. Transfer in the amount of \$5,000.00 dated August 23, 1996 - This was deposited to the Federal Account in error - It is included in the check dated May 8, 1997 for the purpose of transferring-out the incorrectly deposited amount to one of our non-federal accounts.
4. Transfer in the amount of \$20,493.97 dated September 5, 1997 - This was transfer from the TN State Operating Account. Check No. 1006 (A copy of the check is enclosed).


