California Farm Bureau Federation sponsors a separate segregated fund (SSF) incorporated under the name California Farm Bureau Federation Political Action Committee (FARM PAC®). Its FEC identification number is C0041954.

Recently we learned that Missouri Farm Bureau Federation sponsors six similarly-named SSFs, all beginning with the name Missouri Farm Bureau Farm Pac. Following that common name in each SSF are these six designations, respectively: Southwest District; Southeast District; Northeast District; Northwest District; West Central District; and St. Louis Area.

After searching your records, please inform me of the date of the first registration with the FEC of these six SSFs in which the term Farm Pac was used in the SSF's name.

Further, if it is feasible to do so, please search the entire FEC database of SSFs to determine whether the term Farm Pac has ever been used in the name of any other SSF besides those sponsored by Missouri Farm Bureau Federation and California Farm Bureau Federation. If so, please inform me of the name, address, FEC identification number and registration date of each such SSF.
