Dear Sir or Madam:

The Virginia Tea Party Alliance Political Action Committee (also referred to as "Virginia Tea Party Alliance PAC" or "VTPA-PAC"), a division of Tea Party Alliance, Inc. ("TPA"), a Virginia non-stock corporation / IRS 527 organization, through this letter and the attached FEC 1 Statement of Organization, files with FEC as an independent expenditures committee, popularly referred to as a "super PAC", in keeping with the US Supreme Court's ruling in *Citizens United v. Federal Election Committee*, 558, US 08-205 (2010), and its progeny.

VTPA-PAC with regard to its participation in federal elections in support or opposition to federal candidates for nomination or election to office will not coordinate with federal candidates. Neither will VTPA-PAC contribute directly to federal candidates, and thus would not be subject to traditional or former expenditure limits, in accord with the Supreme Court rulings noted.

With regard to TPA's support or opposition to candidates for state or local offices, TPA, including VTPA-PAC, will of course follow state and local election laws and regulations. FEC does not appear to have jurisdiction in state and local elections; it's regulations do not apply. TPA will follow federal laws and regulations of other agencies, such as IRS, in state and local races, as applicable. In states such as Virglria for example, state election law allows for coordination with candidates for state office, subject to reporting conditions. TPA, including VTPA-PAC, would therefore participate in these kinds of lawful state and local election activities.

Please let me know if you have questions, concerns, corrections, and please let me know that Virginia Tea Party Alliance PAC / VTPA-PAC is registered with FEC as an independent expenditure PAC. VTPA-PAC and TPA welcome full communication from the FEC, appreciate its guidance, and seek to comply with all applicable laws and regulations.
