This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in an audit or enforcement action. Additional information is needed for the following item:

Line 11(a)(i) of the Detailed Summary Page of your report discloses a total of \$2,680 in Individual Contributions (Itemized). The sum of the entries itemized on Schedule A supporting Line 11(a)(i), however, indicates the total to be \$1,115. Please amend your report to clarify the discrepancy.

- 2 U.S.C. §434(b)(3) requires itemization of contributions from individuals and persons other than political committees, where the aggregate total from the contributor exceeds \$200 in a calendar year.
