This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following item:

✓ / Line 11(a)(i) of the Detailed Summary Page of your report discloses a total of \$2,680 in Individual Contributions (Itemized). The sum of the entries itemized on Schedule A supporting Line 11(a)(i), however, indicates the total to be \$1,115. Please amend your report to clarify the discrepancy.

✓ - 2 U.S.C. §434(b)(3) requires itemization of contributions from individuals and persons other than political committees, where the aggregate total from the contributor exceeds \$200 in a calendar year. 
