1. Line 7, Columns A and B of the Summary Page does not equal Line 31, Columns A and B of the Detailed Summary Page. Please amend your report to correct this discrepancy. (11 CFR \$ 104.3(c))

2. Schedule B of your report discloses reimbursements to individuals for CONVENTION" "LEAP and "NATIONAL BUILDING TRADES CONVENTION." Please be advised that when itemizing reimbursements to individuals for goods or services, if the payment to the original vendor aggregates in excess of \$200 in a calendar year, a memo entry including the name and address of the original vendor, as well as the date, amount and purpose of the original purchase must be provided. Please amend your report to include the missing information and clearly identify on the Schedule B, which reimbursement each memo entry relates to. If itemization is not necessary, you must indicate so in an amendment to this report. 11 CFR §§104.3(b)(3)(i) and 104.9, and Advisory Opinions 1992-1 and 1996-20, footnote 3
