The individuals who maintain these tables are not employees of the committee and therefore not subject to 11 CFR 300.33(c)(2). Republican Campaign Committee of New Mexico does not use any national party transfers to fund Federal Election Activity. The party utilizes a strict accounting method to ensure that national party transfers are being used only for permissible administrative and overhead expenses. This accounting method also guarantees that all Federal Election Activity is being funded by contributions raised under the limitations and prohibitions of the Federal Election Campaign Act, as amended. The employees reported on H4 do not spend more than 25% of their time on federal election activity and therefore are not subject to 11 CFR 300.33(c)(2). The payments to individuals for office cleaning and computer consulting reported on H4 are not employees of the committee and therefore are not subject to 11 CFR 300.33(c)(2).
