
-On Schedule H4 supporting Line 21(a) of the Detailed Summary Page, you have failed to include the total EVENT YEAR-TO-DATE amount for a payment(s) to United Broadcasting Co., Inc. Please amend your report to include the missing EVENT YEAR-TO-DATE total(s).

-For future reporting, please be advised that only contributions to federal candidates and political committees should be itemized on a separate Schedule B supporting Line 23 of the Detailed Summary Page. Contributions to non-federal candidates and committees should be itemized on Schedule B supporting Line 29.

-Your report discloses several totals on the wrong lines of the Detailed Summary Page. For future filings, please refer to the instructions contained on the forms to ensure the totals are placed on the appropriate lines.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
