This letter is in response to RFAI dated April 30, 2018.

1. Due to a computer program issue, the Action Committee for Rural Electrification (ACRE) 3/19/2018, \$1,500 Primary election contribution did not report as a redesignation as intended, but as three separate contribution transactions (\$1,500 Primary, \$500 Primary and \$1,000 General). This computer program issue has been resolved, and the redesignation reports correctly in this Amendment.
