Our PAC counsel at Perkins Coie, LLP has informed us that the FEC regulations require Afognak Native Corporation – Alutiiq PAC to formally request a refund of \$2,6000 from our contribution on April 27, 2009 because 60 days have passed since the contribution was made. (I confirmed this by referring to 11 CFR 110.1). Thus, I believe we must officially request and receive a refund and then we will be able to make additional contributions to Senator Inouye's general election campaign and his leadership PAC.
